### 1 Important Dates

### 2 ICAR General Meeting – Wednesday 2<sup>nd</sup> June 2005

- Task Force on International Beef Genetic Evaluations identified a good opportunity for Interbull to extend its range of services. Will be discussed further over the next few days.
- A benchmarking service for Milk Recording organisations is being expanded with a lot of interest being expressed by member countries. Ireland will participate in 2005.
- Biennial Conference of ICAR & Interbull will be held in Finland in early June 2006. This represents a good opportunity for Irish breeding organisations to learn more about developments in other countries. Any ICBF member interested in participating should contact Brian Wickham for details.

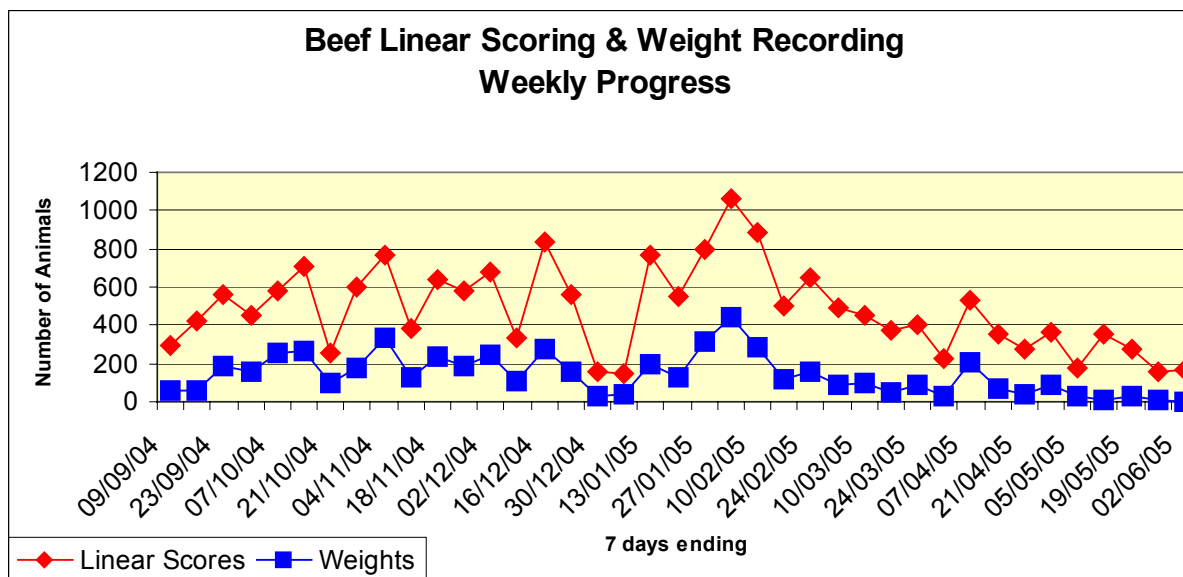
### 3 Code of Ethics for Breeding Organisations – Workshop on Thursday 2<sup>nd</sup> June 2005

- A voluntary code of ethics has been developed for use by European animal breeding organisations.
- This code has value for Irish organisations by helping to ensure all issues are considered when breeding strategy is being decided in providing transparency and in ensuring the wider community supports our activities.

Several papers from Ireland describing beef and dairy genetic evaluation work are being presented, a report will be provided in next weeks update.

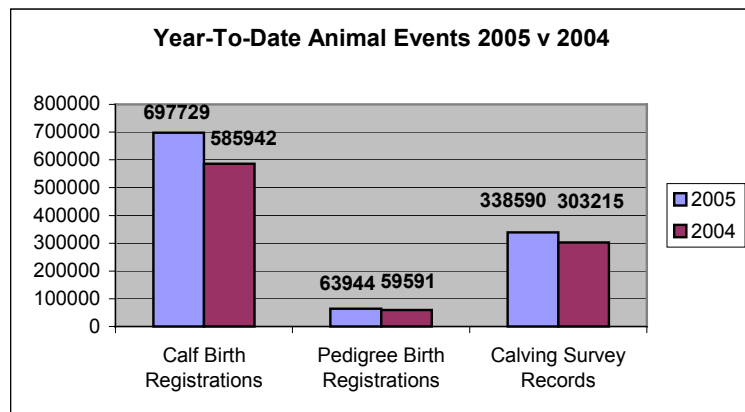
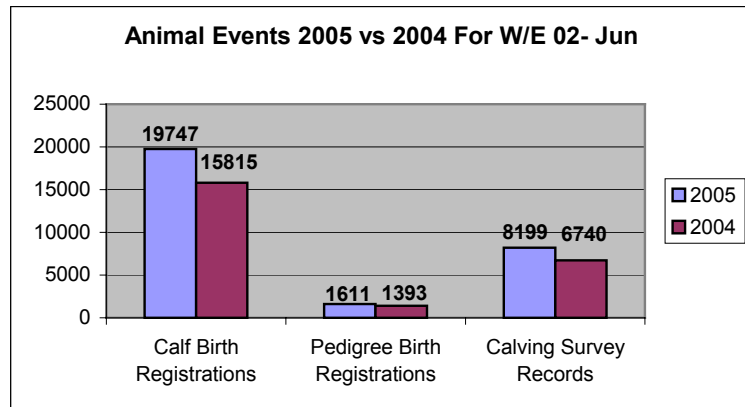

## 6 Database Update

- 35 New Herds added to the database in the past week.
- Comment from the staff in the Animal Events (AE) office: "*AE registrations decreasing weekly as is new herd permission forms. Large numbers of missing sire reports are still being returned.*"
- 4899 Teagasc ICBF permission forms have now been returned by Teagasc clients.
- Initial feedback from the linear scorers on the re-designed linear scoring application has been positive. The building of the application is expected to be finished on June 15th, with two weeks of testing planned subsequently.
- The Tully developments for data entry were handed over to Michael Barron this week and will be used during the performance test of the current intake.
- The development work on enhancing the catalogue generation functionality from the database is continuing.
- A test Dairy Genetic Evaluation run will begin this weekend with the beginning of the extraction process. The purpose is to ensure an effective knowledge transfer between the outgoing and incoming geneticists.
- 8,500 Spring Dairy Calving reports were distributed this week. Work has begun on the Beef Calving Report.



## 7 Tully

- The minutes from the Tully review meeting were sent out to all who attended on the 30-5-05.
- A total of 54 bulls for the May intake have entered Tully, another 15-20 bulls will enter before the 6-6-05.
- A group of 33 Limousin breeders from Germany will visit Tully on 4-6-05.
- A group of 18 beef farmers visited Tully on 2-6-05.

## 8 Staffing - Geneticists

- As part of our ongoing strategy to ensure Dr. Grogans contributions are continued we have appointed Timothy Byrne to a nine month position at Tully. Timothy has a Masters Degree in animal breeding from Massey University in New Zealand and considerable experience in beef cattle. His main task at Tully will be to help ensure a smooth changeover to the use of the new beef evaluations.



## 9 Milk Recording

### Industry Test Turnaround May 2005.

Industry national average for May was 6.55 days. The Organisation with the best turnaround was **Kerry** with an average of **5.08 days**. Each month every MRO gets an ICBF Intranet Report on their respective turnaround performance. This gives the Organisations the details on how much time is taken in the different steps in the milk recording process.

## 10 Teagasc Moorepark Open Day 2<sup>nd</sup> June 2005
